The table below and additional text indicates costs that a user should be aware of and can expect as well as contracts, disclosures and limitations.

Related to ScriptSure EMR application	Costs
Support	<i>On-going annual fee that is a percentage of the overall initial cost or it is included in a monthly fee if the product is licensed in that way.</i>
Drug Database Usage	<i>There are continual fees for use of the drug database that is separate and distinct from annual support. This amount is included in monthly fees, but not flat purchase.</i>
Document Storage	<i>A yearly fee for document storage.</i>
Optional Prescription Printing	<i>One-time costs for prescription-sized printer and continual costs for secure prescription paper as needed.</i>
Setup and Installation	<i>Initial one-time setup fees for each Provider user and fees for locations with more than 3 computers.</i>
Reinstallation	<i>One-time fees for reinstallation on individual computers.</i>
Optional: Offsite Backup service and software	<i>One-time software fee plus annual fees for storage of the data.</i>
Custom report generation	<i>One-time fee.</i>
Custom export of patient data for migration	<i>One-time fee.</i>



3rd party integrated apps in ScriptSure	<i>ScriptSure contains the ability to add 3rd party applications. These applications typically carry monthly fees for their use.</i>
Data Interfaces	<i>Custom programming to interface to 3rd applications for sharing data is typically a one-time fee, but in certain circumstances can carry annual maintenance fees depending on complexity.</i>
E-Prescribing Controlled Substances	<i>For users that would like to Electronically prescribing controlled substances (EPCS), there are nominal additional monthly or annual fees and there is a requirement to purchase a 2-factor authentication hard token device or soft token for secure sending. There is an additional cost that may need to be paid to third parties for these security tokens.</i>

Contracts & Limitations

All users must sign a contract for use of the ScriptSure products. The term of the contracts can be for 6 months, 12 months or shorter/longer durations under certain circumstances.

ScriptSure EMR requires the usage and contracting with Microsoft HealthVault for patient portal.

For users that would like to leverage document storage, you can select Google Drive for an online storage provider. This requires contracting with and pay fees directly to Google.

All users must accept End User License Agreement (EULA); available to users prior to purchase.

ScriptSure functions on Windows-based computer and tablets.

Any users that want to EPCS, must purchase a security device and security certificate.

Microsoft Office, including Word and Excel are required for printing certain documents and reports in ScriptSure. Microsoft is not included in the ScriptSure software purchase and must be purchased separately at the end user's cost.
